iii. Report from – *Leaping*

Comments: Commissioner Leaping informed that Class A Lawn Care's contract is up March 2015. Lawn Co. will take over April 2015, the total service approved for the budget is \$6000.

vi. Report from – *Estes*

Comments: Commissioner Estes spoke with Kentucky League of Cities regarding the Thomas Jefferson property and was informed that Crossgate must have a land lease with Thomas Jefferson in order to use city funds to maintain it. v. Report from – *Yeager*

Comments: Commissioner Yeager would like to propose a possible ordinance to restrict street parking when the city receives any snow. Commissioner Yeager reported two instances of damage due to snow removal by Nally, Crossgate's salting and city roadside plowing contractor. Commissioner Yeager would investigate as to what the consequence is for damage from the removal of the snow by Nally. Commissioner Yeager reported that the Nally contract will be up in April and the city will obtain quotes for new service. Commissioner Yeager will need all road patching quotes by May 2015 meeting.
