

# City of Crossgate

## Ordinance Number 01 Series 2000

An ordinance relating to the closing of Grantham Place, a vehicular way totally within the corporate limits of the City of Crossgate, a 6-class city in the Commonwealth of Kentucky.

WHEREAS, it is the desire of the Council of the City of Crossgate to control vehicular traffic within its corporate limits.

WHEREAS, all the vehicular ways within the City are maintained by the City.

WHEREAS, Kentucky Revised Statutes 82.405 allows such Cities to control vehicular access.

WHEREAS, notification of this proposed change has been given to the residents abutting Grantham Place, the vehicular way proposed to be closed.

WHEREAS, notarized consent of all affected property owners has been received.


WHEREAS, this ordinance has been introduced, had a second reading and received an affirmative vote of the majority of the members of the Council of the City of Crossgate;

Therefore, be it ordained by the City of Crossgate;


The right-of-way of the vehicular roadway known as Grantham Place is hereby closed to all traffic except those vehicles entering from Crossgate Lane and Grantham Court, both vehicular ways totally within the City of Crossgate and solely maintained by the City.
