An Ordinance relating to the partial closing of Haverhill Road, a public way totally within the corporate limits of the City of Crossgate, (the "City"), a 6-class City in the Commonwealth of Kentucky.

WHEREAS, it is the desire of the Council to the City of Crossgate to control vehicular traffic and maintenance on public ways within its corporate limits, as well as to promote public safety and welfare;

WHEREAS, all public ways within the City are maintained by the City;

WHEREAS, presently, the sole means of ingress and egress of vehicular traffic on Haverhill Road is by and through Warrington Way, a public way that is entirely within the City's corporate limits;

WHEREAS, the City desires and has proposed to partially close Haverhill Road and to retain and not disturb the present and sole ingress and egress of vehicular traffic on Haverhill Road as by and through Warrington Way;

WHEREAS, the City has proposed that the sole means of ingress and egress of vehicular traffic on Haverhill Road, a public way that is entirely within the City's corporate limits, is, and hereafter shall be, restricted solely to ingress and egress by and through Warrington Way;

WHEREAS, the proposed partial closing of Haverhill Road does not impact or effect a closing or partial closing of Warrington Way or any other public way in the City;

WHEREAS, Kentucky Revised Statute § 82.405 authorizes and allows the City to control vehicular traffic on public ways within the City's corporate limits;

WHEREAS, pursuant to KRS § 82.405(1) and (2), the City finds as fact that it has identified all property owners in or abutting Haverhill Road, the vehicular way proposed to be partially closed;

WHEREAS, pursuant to KRS § 82.405(1) and (2), the City finds as fact that it has given written notice of the proposed partial closing of Haverhill Road to all property owners in or abutting Haverhill Road of the partial closing of Haverhill Road.

WHEREAS, pursuant to KRS § 82.405(1) and (2), the City finds as fact that all property owners in or abutting Haverhill Road have given their written, notarized consent to the

partial closing of Haverhill Road, and copies of such consents are attached hereto.


WHEREAS, this Ordinance has been introduced, has had a second reading and received an affirmative vote of the majority of the members of the Council of the City of Crossgate;

Therefore, be it ordained by the City of Crossgate;


The right-of-way of the vehicular roadway known as Haverhill Road, a public way totally within the City of Crossgate and solely maintained by the City, is hereby partially closed of ingress or egress for vehicular traffic. The right-of-way of the vehicular roadway known as Haverhill Road is hereby closed to all vehicular traffic except those vehicles entering from Warrington Way, an intersection at the Northeast end of Haverhill Road, and also a vehicular way totally within the City of Crossgate and solely maintained by the City. Hereafter, the Southwest end of Haverhill Road is closed and shall not be used for vehicular traffic for ingress or egress of Haverhill Road.

Further, that this Ordinance shall be recorded in the Office of the Jefferson County Clerk.


