

Corrective Maintenance Work Recommended

1. Replace missing plants and lirope;

2. Reduce beds; repair erosion; add topsoil to grade and sod to finish;

Realign irrigation heads for proper operation (heads are bent over and not straight in the ground causing improper water patterns).

An estimate for the above work can be provided upon request. Again, it is recommended that this work be completed prior to any landscape maintenance work being done for cost effective reasons.
