#### ii. Commissioner's report – *Kirschenbaum*

Comments: Commissioner Kirschenbaum gave an update of the new residents to Crossgate: Josh and Sarah Portman at 1902 Grantham Ct; Scott and Keliegh Lebre at 1806 Warrington Way. The welcome committee will give each new neighbor a welcome basket.

Commissioner Kirschenbaum requested a welcome committee line item of \$1000 for welcome expenses for FY 2015 - 2016. Treasurer Tom Elmes mentioned that there was already a line item for gifts and gratitudes. The Commission agreed to give the Welcome Committee a \$1000 budget out of monies already allocated for gifts, etc.

### iii. Commissioner's report – Estes

Comments: Commissioner Estes was absent, however a few neighbors asked about the Crossgate Neighborhood Yard Sale. It was suggested that Crossgate hold this annual event in the Spring, in conjunction with Graymoore Devondale. It was also suggested that Commissioner Estes 'survey' the neighborhood to ensure the residents are still interested in a neighborhood-wide yard sale.

#### iv. Commissioner's report—Yeager

Comments: Commissioner Yeager gave an update from KLC and whether the City of Crossgate could use Hall Contracting to pave the city roads without bidding the entire job to two other companies. Commissioner Yeager and Mayor Hilbrecht would continue to ensure that if Crossgate could use the Metro contract that Hall Contracting was under, paving would transpire in 2015.

To ensure that the Crossgate Ordinance 2015-03, Transfer of general funds to road funds, would result in potential payment of a paving contractor, Commissioner Yeager introduced the following motion:

"That upon the finalization of obtaining a paving contractor to pave the city roads of Crossgate in accordance with the policies and regulations stated by KLC, that the City of Crossgate would commission a paver to pave the roads of Crossgate with a budget not to exceed \$124,000 for FY 2015-2016."

Discussion: This motion was introduced based on the good faith statements of Hall Contracting stating this company held a Metro City/KY State contract that would allow the City of Crossgate to hire Hall Contracting without a competitive bidding process, in accordance with KRS. 45A.070.
