2nd Reading of the 2016 – 2017 Crossgate Budget Ordinance

Comments:

• It's ok to send out ordinance information in the meeting agenda to residents ahead of time. For the parking ordinances before we discuss it as part of the agenda, we will inform the residents that discussion at the meeting is coming up.

Discussion:

- Estes: The \$15,500 property tax pushed to December, \$30,000 in November, and the other numbers to next January/February.
- Estes: Should have a total income each month.
- Estes: Surplus deficit should be \$0, adding the \$4,627 to reserve.
- Budget responsibilities breakdown:
 - o Above the line is revenue which the Treasurer is responsible for tracking,
 - o Commissioner Estes can provide budget oversight,
 - o Relations and activities is Commissioner Wajda,
 - o Contract police is Commissioner Gerrish,
 - o Contract web is Commissioner Waida.
 - o Contract snow is Commissioner Gerrish,
 - o Contract garbage and grounds is Commissioner Gerrish,
 - o Contract accounting is Treasurer,
 - Contract consulting can be any Commissioner but oftentimes results in Commissioner Kirchenbaum or Commissioner Gerrish,
 - o Contract "other" depends on the situation.
 - o Contract dues and subscriptions is Mayor and Treasurer,
 - o Equipment rentals, Insurance, and office expenses is Mayor and Treasurer,

- Payroll and Payroll taxes is Treasurer,
- o Rent, utilities, and building maintenance is Treasurer,
- o Road maintenance and capital improvement, the group.

- Reached out to the attorney regarding the parking ordinances. Do we want to put in no parking signs at entry and exits? We'll have an interlocal cooperation agreement with Graymoore. Crossgate will nominate two representatives to sit on that board if there are appeals that come through. Proposed fines and penalties: first offense is a warning, second offense \$50 fine, third offense \$100 fine, fourth offense is towing.
- Mayor: would like to have an ordinance in place to address using housing as an Air B & B rental and rentals, that the Commission needs to be notified when someone is renting. Discussion ensued regarding business activities, zoning and safety.

• Mayor has four RFPs for the paving project: Louisville Paving, Flynn Brothers, Hall, and LIBS Paving (Indiana). The quotes include the difference between and overlay and milling.
