- Statement from Angela Leet: I regret that my schedule does not allow me to be with you all today, but in my review of this proposed change in zoning it appears that the applicant and the City of Crossgate have worked out a proposal that is mutually beneficial. However, while I understand from watching the hearing and reading the minutes that the City of crossgate is supportive of this project and the change in zoning for tract 2 they have not yet made that support official and they are schedule to do so at their upcoming meeting on Monday. If the City votes to approve the plan then I look forward to supporting this proposal when it comes before the full Metro Council next Thursday.
- City of Crossgate cannot vote until receipt of binding elements.
- VA: our Attorney's are working on paperwork Crossgate can file if that direction is chosen. The VA process is being reviewed and neighborhood impact is being considered along with conferring with other area attorneys. Potential special meeting to review.
