- Is there an update on sinkhole repair and recycle bins with pulls?
 - (Commissioner Gerrish) Waste Management does not provide bins with pulls/rollers. For Waste Management to come to the house it would be an extra fee and less than 5% of residents in the City of Crossgate would be able to take advantage of that service.

v. Commissioner's report – Commissioner Gerrish

Comments:

- Last month we approved Louisville Paving to mill and pave the roads in the City of Crossgate. Donnie Miller is here to answer any questions.
 - O (Miller) Each stage is roughly 2.5 days milling, then paving. Louisville Paving will have traffic control through the process (either flaggers or police). The line projection from the road will go in a straight line across drives to keep it an even level from drive to road. One lane at a time will be milled & paved, side roads first, and it takes about an hour to do a cul de sac round. Depending on backlog and weather it may take 3-4 weeks to start, with a focus to try to complete prior to the start of school. If there are parked cars on the street, there will be a removal process.
