### Comments:

- MSD contacted by Yeagers:
  - Went to Metro Council Town Hall meeting in September and met with Joe Exsley, project manager for MSD.
  - The drainage is supposed to empty into midlands, it's done incorrectly. MSD will make it a priority and move funds around to get it fixed. The VA Hospital cannot build until this is taken care of. The VA has not submitted plans to MSD yet.
    - Q: Will MSD replace the pavement they destroy during the correcting process?
- Treasurer need copies of contracts still working on gathering all of them. May need help finding them all or getting copies.
- Haven't renewed Nalley's commitment for salting yet, will have finished by end of October.
- Need guidance on finding the light post with sinkhole will check it out.
- Proposing getting storage space 5' x 10' temperature controlled for \$97/mo. for records, decorations, etc.
