- A Steering Committee has been formed to stay on top of the situation and encourage support from surrounding communities: Mayor Hilbrecht, Commissioner Wadja, The Yaegers, and a few Northfield residents. There are packets of information with the plan.
- We secured a 30-day comment extension.

- Getting traffic study experts to get involved at no cost to Crossgate.
- Northfield is appropriating \$10,000 for the VA Hospital issue, Old Brownsboro Place \$5,000, and still working on other surrounding cities.
