 - An email has been sent with contact information, as well as paper canvassing of the neighborhood, for Metro Council to communicate regarding KRS82.040
 - On the 13th the City of Crossgate approved and signed the Ordinance and notified the City of Crossgate residents of KRS82.040 via email and paper copies wanting their signatures stating they agree and concur.
 - o Also contacted League of Cities to confirm compliance.
 - 51 of 92 Households have signed re: KRS82.040 giving approval of authority. We are still collecting, but do not have to have 100%. There is also no minimum number required.
