v. Commissioner's report – ***Commissioner Krish***

Comments:

- Researched short term rental regulations. Owners have to register the property and possibly need a conditional use permit. There is a possibility enact a Tax Ordinance on that type of property. Other ordinances can be made to restrict short-term rentals. Mayor request: canvas neighborhood as a first step to discover how many short term properties are in the City of Crossgate to have solid information that will determine if next steps are needed for additional ordinances.
- Met with Chief of Graymoore-Devondale Police. They caught the suspect of the latest break-in. 90% of burglaries occur during the day. If you have a security system, make sure the sign is visible as it does help to deter potential thieves. For the traffic and parking issues, they are clear on the ordinances and expectations, and a radar sign will be put out for use. Mayor request: research ordinance for speed bumps and speed changes.
