- VA UPDATE: We are halfway through the 90-day waiting period. Strobo-Barkley is still actively working on the case. There is a 130-page document submitted as the City of Crossgate's grievance. Depending on the health safety status of the courts by the end of the waiting period, the Judge will then make a ruling whether or not there will be full lawsuit proceedings. Discussion ensued regarding traffic studies, experts used, and the reminder that the VA has admitted to not following their own rules and processes. Basically, the City of Crossgate is in waiting mode.
