B. Mayor's Report – Mayor Hilbrecht Neighborhood Walk/ 'Good Will Patrol' Task Force – w/R. Sweeney

Comments:

- Recently spoke with Todd Underhill, Developer of Westport Village. He has
 expressed interest in the KABA property. There is currently another interested party
 that has an offer submitted. That purchase has not been finalized. Ideas for
 development are patio homes/apartments. Nothing has been approved and for
 development to happen there would need to be a change of zoning.
- VA: We have a call in to Strobo-Barkley. We won't hear anything about the case from the courts until August.

- (Larry) If we want food trucks, we should get some scheduled soon because they book quickly.

6. Open Forum.

Comments:

- (Tom) There is mention of \$18,000 to pay the Attorneys, are we disputing the bill?
 - o (Mayor: No, the \$18,000 brings all work current, any future work we are to be notified prior to the work being executed so there are no surprise bills.)
 - (Treasurer) There is still an outstanding bill that would be us over the budgeted amount).
- (Larry) Are we meeting with the surrounding cities to get help with the VA?
 - o (Mayor) Yes, those meetings are being scheduled now to get aligned support.

- (Tom) Who brought the tax increase to the table? How did the Commissioners vote?
 - o (Mayor) We started the 2020-21 Budgeting conversation in March, in May we had the First Reading of the Ordinance, and in June for the Second Reading we figured we were budgeting more than we would be bringing in. On that call we started cutting line items down to streamline. The Road Fund was the big project that depletes from General Fund. Other areas were also being cut. Then we questioned what it would look like to increase taxes via different options. We chose the mid-level option. The Commissioners voted unanimously.
 - o (Tom) What are the tax rates for the surrounding cities? I believe we are extremely over those. Did we consider that before increasing the tax rate?
 - O (Krish) We found Northfield. There's was roughly ~16.8 cents per hundred, Indian Hills was in the 20 cent range, further down 22 was ~17.8. Compared to those neighborhoods we are drastically smaller in size, and that has an effect.
 - (Mayor) We did the online search and density of the neighborhoods as well as the average residential property values and the commercial property. Not sure how to do an apples-to-apples comparison.
 - o (Krish) Compared our budget to another comparable city, ours is on-par with theirs.
 - o (Gerrish) We also compared services provided within Crossgate compared to others, we also talked about multiple other things such as there has not been a tax increase in over 20 years, a review of projected services over the next 5 to 10 years, and the road fund would not sustain a repaving in the next 10 years without an increase in revenue.
- (Tom) What positions are open in November?
 - O (Mayor) We will have a Commissioner position that will be open. There are three that have committed to run for a seat, that leaves one available. That would have to be a write-in ballot due to the deadline to register for intention to run for the Commissioner position as a name on the ballot was June 24. You have until October 23 to register as a write-in candidate through the Board of Elections.
- (Councilwoman McCraney) Making myself available for any questions you might have about what is going on downtown with protests, or anything the Metro Government is involved in.
 - o (Mayor) May need to have a conversation about any upcoming zoning issues and any support programs that we should be taking advantage of like trees.
