- Joanie Lepping Gillis: Have we had any updates on the front property? When will we know about the sideroad access approval? I want to make sure we as a City are still advocating for the safety of the Warrington side.
 - Mayor: No update and at this point we do not have an Agreement to approve or disapprove that would affect the road access.
 - The Highway department has been in discussions about widening the Old 42. There is a traffic meeting coming up on July 21st.
 - We as a City have no influence of what can be built on the property. Artis technically still owns the property and the Sina deal is contingent on zoning.
 - The traffic issue on Warrington is current and concerns will increase with a new building in the front property. Currently, this would be the issue to address and solve now. Anyone who works here or lives here needs to stop at the traffic signs and drive within the limit. Those that don't need to be penalized, but we don't know how best to enforce that.
- Abigail McNeil: Any news on when blasting will be completed? We have some debris and cracks happening.
 - Mayor: have the neighbors contact me and I'll forward it on to the appropriate parties, VA Army Corps and HTA, to come out and inspect. No confirmation on end of blasting. It's supposed to subside by end of August.
